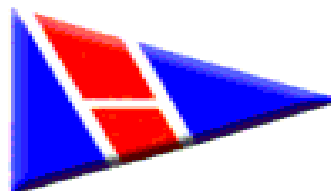

Pool Rental Agreement for Members

- (1) The pool may be rented by a member of Hobcaw Yacht Club for a swimming party.
- (2) So as not to interfere with normal use of the pool by other members, rental is only available outside scheduled pool hours (or at the discretion of the Pool Manager)
- (3) Pool Rental is on one hour increments.
- (4) **Rental does NOT include any use of the club house or back porch to the club house (these areas are rented separately and may be in use by someone else.)**
- (5) No loud music is allowed. No DJ's or live bands allowed. Moderate radio/CD music is acceptable as long as it does not disturb our residential neighbors or use of the club house. The lifeguards or pool manager will be the solo judge of an acceptable volume level. Failure to comply with this restriction will require immediate cancellation of the party with no refund of the rental fee.
- (6) Duration of the event and/or the number of attendees may be extended at the request of the renter subject to:
 - (1) The availability of lifeguards
 - (2) Payment of appropriate additional fees
 - (3) Concurrence of the pool manager
- (7) The renter is responsible for cleaning up their trash and belongings at the conclusion of the event.
- (8) Renter is responsible for any property damage beyond normal wear and tear.
- (9) Attendees will adhere to pool safety rules.
- (10) Rentals are on a first come first serve basis based on the receipt of a completed form along with payment of the rental fee.
- (11) Rentals cancelled 7 days prior to the rental date will be refunded in full. Rentals cancelled with less than 7 days notice will incur a cancellation fee.
- (12) If inclement weather occurs the day of event, renter will receive a full refund.
- (13) Rentals subject to the availability of life guards
